PRAYER :-

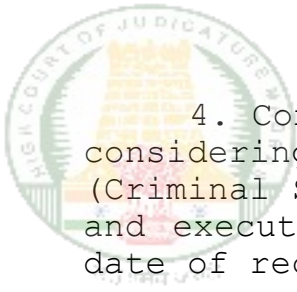
