PRAYER :-

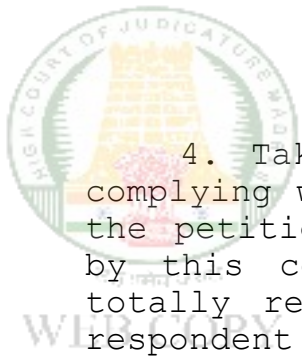
To relax the condition imposed in Crl.OP(MD)No.19548 of 2019
