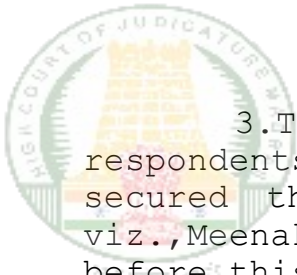

This petition has been filed seeking direction to the respondents 1 and 2 to secure the petitioner's wife namely Sivaranjani, aged about 30 years and his minor daughter namely Meenakshi, aged about 6 years based on the petitioner's complaint dated 13.01.2020.

2.The learned counsel appearing for the petitioner would submit that petitioner's wife viz., Sivaranjani and his minor daughter viz., Meenakshi were kidnapped by the third and fourth respondents. Since no action has been taken by the respondent police till date, the present petition has been filed.
