Prayer in CRL. O.P.(MD) . No.16212 of 2019:-

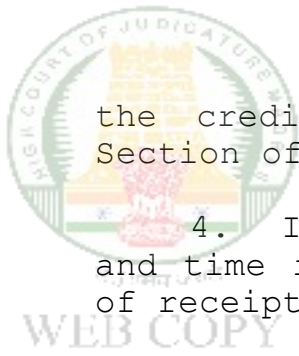
