PRAYER :-

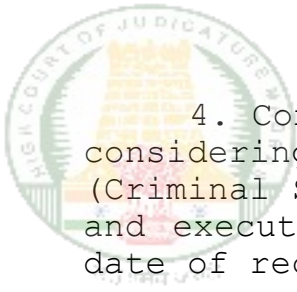
To Extend the Time in Crl.O.P.(MD).No.17182/2019 dated
