Prayer in CRL MP(MD). No.976 of 2020 :-

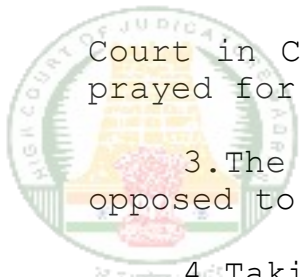
