5. The second respondent is directed to consider the petitioner's representation, dated 21.06.2019 and pass appropriate orders on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order."

6. With the above directions, this Writ Petition is disposed of. No costs.
