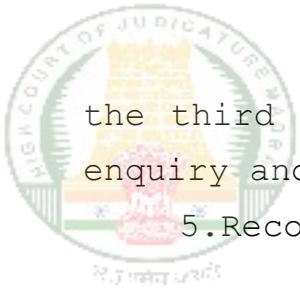
This petition has been filed seeking direction to the respondents 1 and 2 to instruct the third respondent not to harass the petitioners and their family members under the guise of enquiry.
