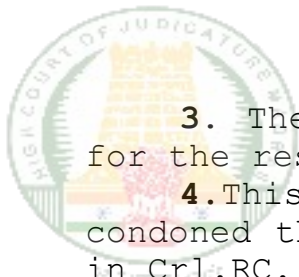
PRAYER IN CRL RC(MD)No.392 of 2010:
