Writ Petition filed under Article 226 of the Constitution of India, praying for the issuance of a Writ of Certiorarified Mandamus to call for the records pertaining to the impugned order passed by the 2nd respondent in Ref.No.ThAaPoKa/ Kumba/ Sattam/ L2/ 21163 / 2016, Kumbakonam, dated 14/02/2018 and the impugned circular passed by the 1st respondent in proceedings in Ref.No.TNSTC/KUMBA/MaVaMe/ Thani/2018, dated 22/03/2018, and quash the same and consequently direct the respondents to settle the petitioner's surrender leave salary for 36 days of Rs.46,800/- from 2011-2014 together with interest at the rate of 18% per annum payable from the date of retirement to till the date of actual payment.
