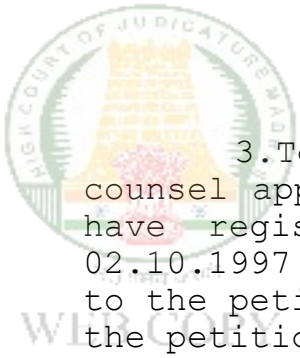

3.Today when the matter is taken up for hearing, the learned counsel appearing for the petitioner submitted that the respondents have registered the petitioner's daughter's date of birth as 02.10.1997 in the SSLC Mark Sheet and the same has also been issued to the petitioner on 05.03.2020. Therefore, the relief sought for by the petitioner in this Writ Petition, is infructuous.

4.In view of the submission made by the learned counsel appearing for the petitioner, this Writ Petition is dismissed as infructuous. No costs.
