PRAYER :-

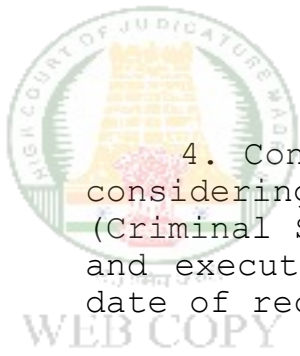
To extend the time for his surrender by another 15 days in
