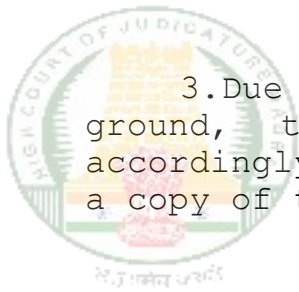
Prayer :-
