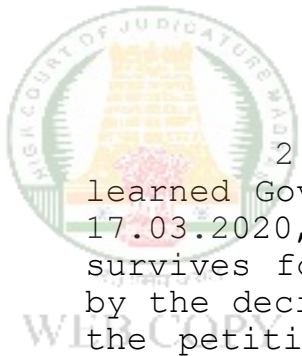
Prayer in WP.(MD).NO.10944 of 2019:
