PRAYER :-

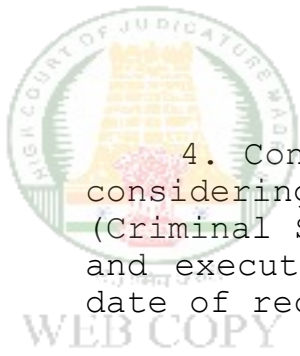
To extend the time of surrender before the Trial Court in
