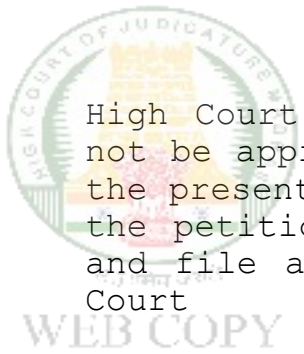

Today when the Writ Petition came up for hearing, the learned Standing counsel for the respondents submitted that challenging the order dated 12.09.2017 passed by the Special Deputy Commissioner of Labour, Chennai, the management has filed a Writ Petition in W.P.No.19389 of 2018, before the Principal seat of Madras



High Court and the same is pending. While that being so, it would not be appropriate to deal with the same order dated 12.09.2017, in the present Writ Petition filed by the employee.
