ORDER

2. Today, when the matter is taken up for hearing, the learned Additional Public Prosecutor would submit that the petitioner's husband is not taken in illegal custody. He was arrested in Crime No.58 of 2020 for the offences under Sections 406,420,294(b), 506 (ii) of IPC and remanded to judicial custody on 19.02.2020.
