PRAYER :-

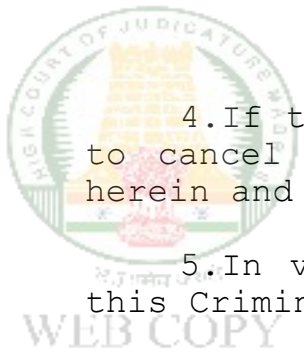
to cancel the Anticipatory Bail order passed by this Hon'ble Court in Crl.OP(MD)No.15354 of 2019, dated 24.10.2019.

ORDER : The Court Made the following order :-

This Criminal Original Petition has been filed for cancellation of the anticipatory bail granted to Muthukumar.

2.The ground for cancellation is that Muthukumar did not abide by the conditions imposed vide order dated 24.10.2019.

3.Today, when the matter was taken up for hearing, the learned counsel for the second respondent submitted that the arrears have since been cleared. The learned counsel gives an undertaking that henceforth the petitioner will scrupulously adhere to the undertaking given before this Court.



4.If this undertaking is breached, this Court will not hesitate to cancel the anticipatory bail granted to the second respondent herein and commit the accused to custody.

5.In view of the subsequent conduct of the second respondent, this Criminal Miscellaneous Petition stands closed.
