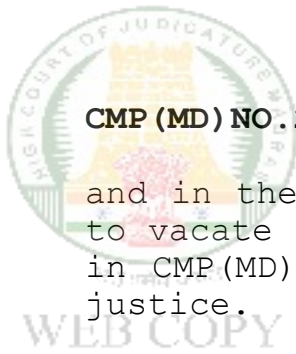

PRAYER IN CRP(MD).NO.244 of 2019:-

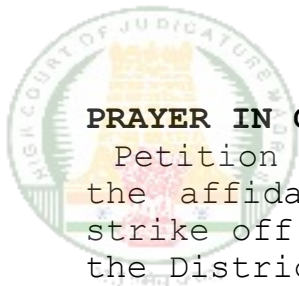
