To grant extension of time granted in the order made in Crl.OP (MD)No.976 of 2020, dated 23.01.2020 on the file of this Hon'ble Court.

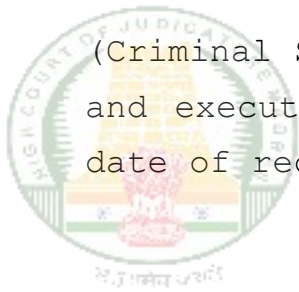
ORDER : The Court Made the following order :-
