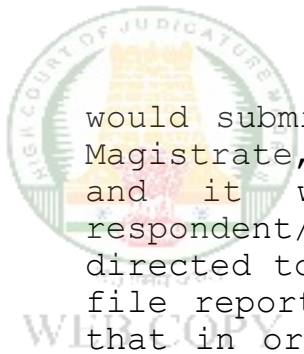

would submit that the fifth respondent has approached the Judicial Magistrate, Antipatti to file petition under Section 156(3) Cr.P.C and it was numbered in Cr.M.P.No.673 of 2020 and third respondent/the Inspector of Police, Kandamanoor Police Station was directed to register the complaint for the cognizable offence and to file report within a period of four weeks. He would further submit that in order to conduct preliminary enquiry, the third respondent has issued summon the petitioner other than they have not harassed the petitioner.
