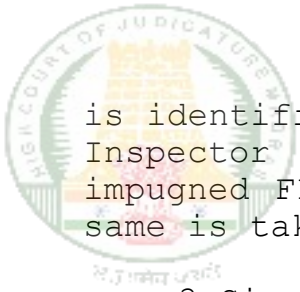

is identified by the learned counsel and A.Chidambaram, Special Sub-Inspector of Police and he has no objection for quashing the impugned FIR. The parties have also filed a compromise memo. The same is taken on record.

3. Since the defacto complainant himself has no objection for quashing the impugned FIR in Crime.No.184 of 2014 on the file of the first respondent, the same stands quashed. Accordingly, the Criminal Original Petition is allowed. Consequently, connected Miscellaneous Petition is closed.
