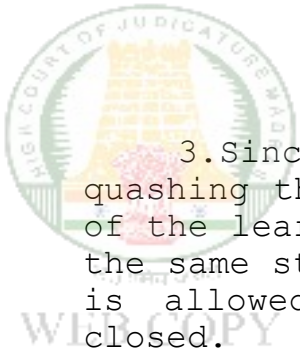

ORDER

The petitioners are facing trial in C.C.No.269 of 2017 on the file of the learned Judicial Magistrate, Valliyoore for the offences under Sections 147, 148, 294(b), 323, 324 and 506(ii) of IPC r/w 109 of IPC.
