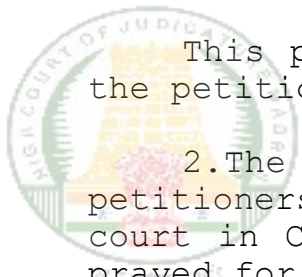
Prayer in Crl.M.P.No.1712 of 2020:-

This Appeal is filed under Section 14A(2) of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act,2015,to call for the records pertaining to the order dated 23.01,2020 made in Crl.M.P.No.78 of 2020 on the file of the Sessions Judge, Special Court for Trial of Cases registered under SC/ST(POA) Act,1989, Ramanathapuram and set aside the same and enlarge the appellants on bail in connection with crime No.10 of 2020 on the file of the Thiruvadanai Police Station, by allowing this Criminal Appeal.
