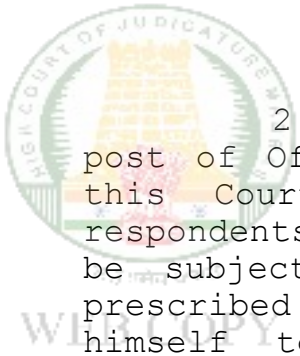

ORDER

By consent of both parties, this writ petition is taken up for final disposal at the stage of admission itself. Since no adverse order is going to be passed against the first respondent, notice to the first respondent is dispensed with.

When the petitioner herein had already applied for the post of Office Assistant through an application dated 21.01.2020, this Court cannot parallelly issue a mandamus directing the respondents to consider his application, since the appointment would be subject to various criteria, requirement and qualifications prescribed for the said post. As and when the petitioner qualifies himself to all the requirements, he would be entitled for consideration and this Court may not be justified in stepping into shoes of the Selection Committee for the purpose of considering the prayer sought for in the present writ petition. Hence, the Writ petition stands dismissed. No costs. Consequently, connected Miscellaneous Petition is closed.
