Prayer in C.M.A(MD)No.SR 23603 of 2019 :

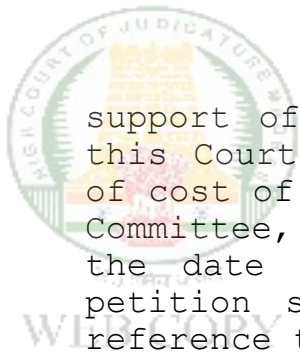
