This Criminal Original Petition has been filed to quash the proceedings in Crime No.87 of 2018 on the file of the Inspector of Police, Pudukkottai Town Police Station, Pudukkottai for the offences under Sections 143 and 188 of IPC.

3.The learned Government Advocate(Crl.Side) appearing for the respondent Police would submit that the facts of the case are similar to the facts covered under the Judgment referred above.

4.Heard the learned counsel appearing for the petitioner and the learned Government Advocate(Crl.Side) appearing for the first respondent Police.
