For Anticipatory Bail in Crime No.128 of 2020 on the file of the Respondent police

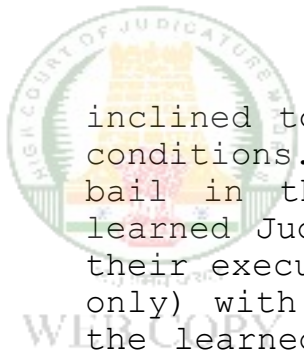
ORDER : The Court made the following order :-

Heard the learned counsel appearing for the petitioner and the learned Government Advocate(Crl. Side) appearing for the respondent.

2. The petitioner apprehending arrest at the hands of the respondent police for the offences punishable under sections 4(1) (aaa) read with 4(1-A) of Tamilnadu Prohibition Act, 1937 and Section 465, 468, 471 of IPC read with 5 and 6 of Tamilnadu Rectified Sprit Rules 2000, in Crime No. 128 of 2020 on the file of the respondent police, seeks anticipatory bail.

3. Considering the facts and circumstances of this case, I am

inclined to grant anticipatory bail to the petitioner with certain conditions. Accordingly, petitioner is ordered to be released on bail in the event of arrest or on their appearance before the learned Judicial Magistrate, Alangudi, Pudukkottai District, and on their executing a bond for a sum of Rs.10,000/- (Rupees Ten thousand only) with two sureties each for a like sum to the satisfaction of the learned Magistrate concerned and on further condition that the petitioner shall appear before the respondent police as and when required for interrogation. The petitioner shall comply with the conditions stipulated under Section 438 Cr.P.C scrupulously.

4. The petitioner shall appear before the concerned Magistrate within a period of 15 days from the date on which the order copy made ready, failing which, the petition for anticipatory bail shall stand dismissed.
