PRAYER IN CRP(MD) SR.NO.64586 of 2019:

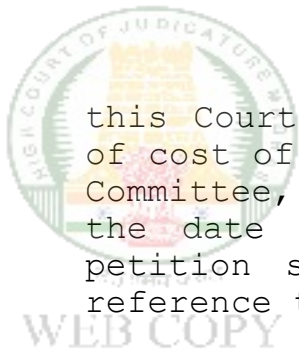
