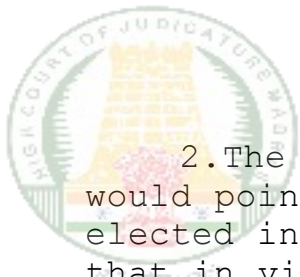

I make it clear that I have not gone into the merits of the matter. No costs. Consequently, connected miscellaneous petition is closed.
