PRAYER IN CRL OP (MD). 7301 OF 2018:-

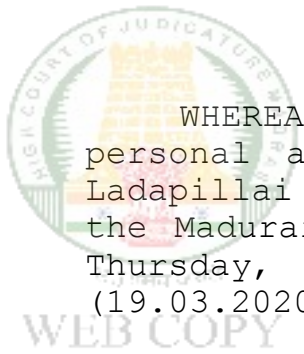
