For R1 & R2 : Mr.A.Robinson

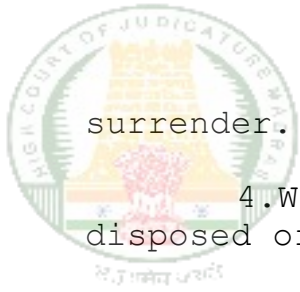
