PRAYER :-

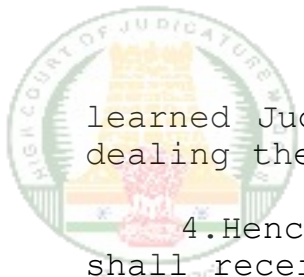

ORDER : The Court Made the following order :-

Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the State.

2.The learned counsel submits that the subject matter is dealt by the learned Additional Mahila Court, Magisterial Level, Ramanathapuram, but inadvertently, in the anticipatory bail petition, he has wrongly mentioned as learned Judicial Magistrate No.I, Ramanathapuram. Hence, seeks for amendment in the order copy.

3.The learned Additional Public Prosecutor appearing for the State submits that though the Additional Mahila Court has been constituted, there is no Presiding Officer and since it is the



learned Judicial Magistrate No.I, who is in-charge of the case and dealing the matter, so there is no necessity for amendment.
