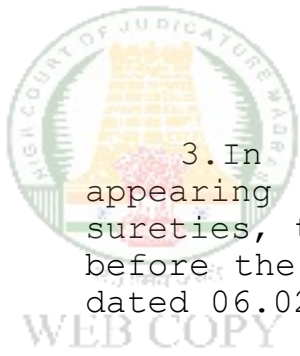
PRAYER :-
