PRAYER :-

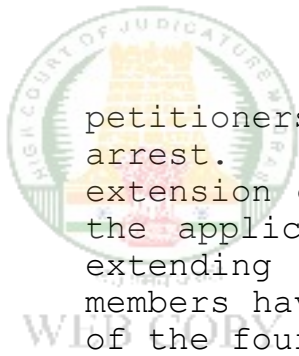

2.The anticipatory bail was granted to the petitioners on condition that the petitioners shall surrender within a period of fifteen days from the date of receipt of the order copy. The

Now, citing the ill health of the fourth petitioner, the extension of time is sought for.

3.This Court finds no *bonafide* in the application. Hence, this Criminal Miscellaenous Petition is dismissed.
