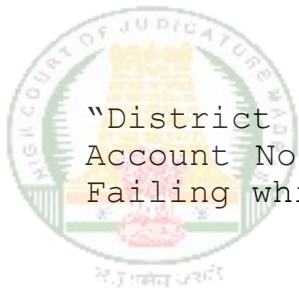
**Prayer in SA(MD)SR.No.66839 of 2019**
