**ORDER**

The petitioner seeks police protection in respect of the petition mentioned land. Further, the petitioner filed an injunction suit in O.S.No.2 of 2020 on the file of the District Munsif, Melur. She also filed I.A. seeking temporary injunction.

2. I am of the view that the petitioner must work out her rights before the civil Court and after succeeding she can move this Court, if necessary for further directions.

3. The learned trial Munsif is requested to dispose of the I.A. within a period of four weeks from the date of receipt of a copy of this order.

4. The criminal original petition stands disposed of.
