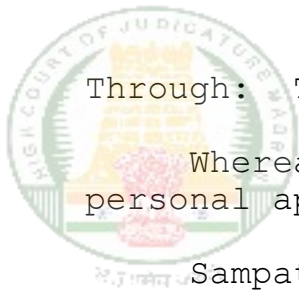
Prayer in WP (MD) . 5176/ 2020 :
