PRAYER: Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents 1 and 2 to direct the 3rd respondent to grant patta to the purchaed land situated in S.No.60/3 of Avaniyapuram, Madurai South Taluk, Madurai District and its extent of 2 cents, 328 sq.fts., (1200 sq.fts.,) by considering the petitioner's representation dated 27.01.2020, within a period of stipulated time as fixed by this Court.

ORDER

4.By recording such submission, this Writ Petition is disposed of. It is open to the petitioner to challenge the said rejection order passed by the 3rd respondent before the appropriate forum, if he is so advised. No costs.
