Heard the learned counsel appearing for the petitioner and
the learned Government Advocate (Criminal Side) appearing for the
respondent.

2. The petitioner apprehending arrest at the hands of the
respondent police for the offences punishable under sections 341,
294(b), 353, 427, 506(i) of I.P.C., in Crime No.52 of 2020 on the
file of the respondent police, seeks anticipatory bail.

3. The petitioner herein infuriated by the act of the
defacto complainant hitting his two wheeler while driving the bus,
has over take the bus and had assaulted him causing injury. The
defacto complainant is driver of the TNSTC bus. The defacto
complainant is a public servant, been assaulted by the



petitioner and the petitioner prevented the Government servant from discharging his duty. Photographs lifted from CCTV indicates that the petitioner has blocked the bus and had attacked the defacto complainant with hands and the spectacles of the defacto complainant broken into pieces.
