4. The learned Government Advocate (Crl.Side) would submit that without filing any bail petition before the Juvenile Justice Board, the petitioners have straight away come forward to file present petitions seeking a direction to the Juvenile Justice Board.

Considering the facts and circumstances of the case, the petitioners are permitted to file appropriate applications before the Juvenile Justice Board and on filing of such applications, the Juvenile Justice Board shall consider the same on its own merits in accordance with law and pass orders on the same day.

6. With the above direction, the Criminal Original Petitions are disposed of.
