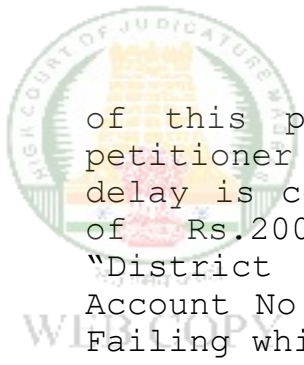
Prayer in SA(MD) No.SR73045 of 2019:

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.R.VIJAYAKUMAR, Advocate for the petitioner, the court made the following order:-

The petition is filed to condone the delay of 130 days in representing the second appeal in S.A.(MD)No.SR73045 of 2019.
