Prayer: Writ Petition is filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, to direct the respondents herein to reckon half of the temporary service rendered by the petitioner as Plot Watcher from 09.08.1983 to 08.08.1993 as qualifying service along with more than 10 years of service as Plot Watcher from 09.08.1993 for the purpose of old pension and other benefits based on the representation dated 28.02.2019 in the light of the order in W.A.No.887 of 2010 dated 29.04.2011 and the proceedings of the Paramakudi District Educational Officer in Na.Ka.No.2648/Aa1/2008, dated 30.04.2012, within a time frame.

ORDER

By consent of both parties, this writ petition is taken up for final disposal at the stage of admission itself.

2.The petitioner herein joined service on 09.08.1993 and in worked for more than 21 years of temporarily service as Plot Watcher. The petitioner had been regulated on 07.08.2009 instead of 09.08.1993 without considering GO(Ms)No.22 P&AR Department, dated 28.02.2006. The case of the petitioner is that the period between joining and regulation was not considered. Hence, the petitioner sent a representation on 28.02.2019. Since the representation has not been considered so far, he filed the present writ petition.



3.This Court, without going into the merits of the case, directs the respondents to dispose of the representation of the petitioner dated 28.02.2019, within a period of 12 weeks from the date of receipt of a copy of this order. Accordingly, this writ petition is disposed of. No costs.
