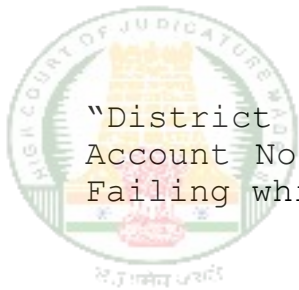
Prayer in S.A.(MD)No.SR72802 of 2019:
