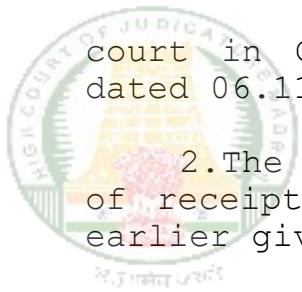
Prayer in CRL MP(MD) NO.2965 OF 2020:-
