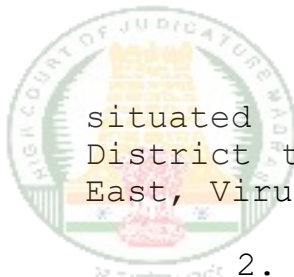

2. When the matter was taken up for hearing, the learned Standing Counsel for TASMAC submitted that the issue as to the shifting of the TASMAC shop is at the stage of infancy and the District Collector, Virudhunagar, is seized of the matter.

In view of the said representation, the District Collector, Virudhunagar, is directed to consider the representation dated 12.03.2020 given by the petitioner and also take into consideration as to whether the opening of the TASMAC shop in the said area would cause any nuisance to the residents of the locality and accordingly, take a decision thereon.

4. With the above directions, this writ petition stands disposed of. No costs. Consequently, connected miscellaneous petition is closed.
