Prayer in CRL RC(MD) No.SR9537 of 2020:

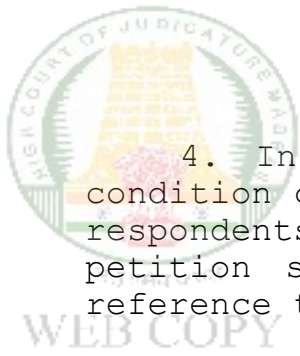
