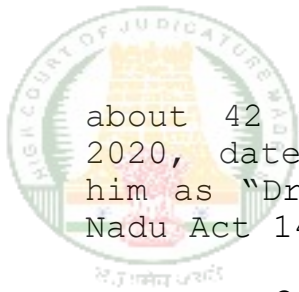

This habeas corpus petition has been filed by the detenu, namely, Suyambulingam @ Kattalingam, son of Kadarkaraiyandi, aged



about 42 years, challenging the detention order in P.D.No.07 of 2020, dated 06.03.2020, passed by the second respondent, branding him as "Drug Offender" as contemplated under Section 2(e) of Tamil Nadu Act 14 of 1982.

When the matter was taken up for hearing, the learned counsel for the petitioner as well as the learned Additional Public Prosecutor for the respondents, by producing a copy of G.O.Rt.No.2019, Home, Prohibition & Excise (XIV) Department, dated 06.05.2020, would state that the impugned detention order has been revoked.

3. Recording the above submissions, the habeas corpus petition is closed.

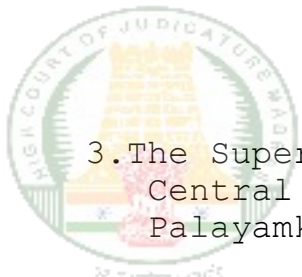
