PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a writ of habeas corpus calling for the entire records pertaining to the impugned detention order passed by the second respondent made in his proceedings in T.N.P.D.A.B.C.D.F.G.I.S.S.S.V.No.06/Goonda/2020, dated 04.03.2020 in detaining the detenue under Section 2(f) of the Tamilnadu Act 14 of 1982 as a Goonda and quash the same and direct the respondents to produce the detenue namely Mohan @ Mohanraj, S/o.Kalimuthan, Male, aged about 21 years, who is detained in Central Prison, Madurai, before this Court and set him at liberty.

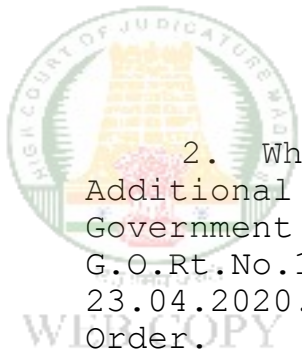
