This Writ Petition filed Under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the respondent Nos.1 to 5 to initiate appropriate urgent actions to provide necessary personal protective Equipments including gloves, mask, gown, face shield, head cover and rubber boots to all the non medical frontline workers viz., Police Personnel, Fire Service personnel, Sanitary Staff, Revenue Officials, Ambulance staff all media personnel and all official and unofficial volunteers within a stipulated time that may be field by this Court along with directions to the respondent Nos.6 to monitor the implementation of the directives of this Court and further report at a periodicity that this Court may decide and pass such further and continuous orders at periodic intervals.

Prayer in WP(MD). 6347 of 2020 :

Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents to appoint the District Level Officer to monitor the Life, Safety and Welfare of the Sanitary Workers of the petitioner Association on the basis of the representation dated 13.4.2020.
